- Your booth space is 10'x10' or 10'x20 as check above, you must provide your own table, chairs and tent for your booth. Booths cannot place displays outside of the 10' x 10'(20') area of the booth space, this includes signs.
- No Power or Water are provided for business vendors booths.
- Vendor must arrive no later than 9:00am and be prepared to serve the public by 10:00am, vendors can begin break-down at 7pm. Any Business Vendor that dismantles or vacates their booth space prior to 7pm, or any booth space that is not occupied before 9am will forfeit their priority status and will not be allowed to participate in the early registration process the following year.
- All vendors are **required** by the City of Yelm to have a Washington State Business License with a City of Yelm [Endorsement](#) -OR- a Washington State Business License and a completed [Special](#) Event Vendor Pass issued by the City of Yelm.
- **All booths are required to have a copy of your business license posted at the event.**
- Any refuse created from your booth needs properly disposed at the conclusion of the event.
- Business Vendors are not permitted to giveaway or sell beverages, meals, snacks. Candy is permitted.
- Business Vendors are permitted to giveaway promotional items, sell retail items & promote their business.
- All Business Vendors have an opportunity to donate a \$25+ valued item to the event to use for raffles. Please drop off your raffle item when you check-in the day of the event or to the chamber office by 7/24/24. We will be announcing your donation from the stage during the event. The Yelm Chamber of Commerce would like to thank you in advance for contributing your valuable merchandise and/or gift cards to our raffle, which is a highlight for the attendees and an important aspect of the event.
- Vendors not conforming to any of the above requirements will be required to leave the event immediately.
