Vendor Agreement & Release of Liability

- Dimensions for your booth or food truck are up to 10'x20' or 10'x/30'/40'(for an added fee).
- Vendor must provide their own table(s), chairs, tent and electrical cords. Booths cannot place displays outside of the 10' x 20' (30/40') area of the booth space, this includes signs.
- Vendors are responsible for following local health, fire, and water quality codes. All food vendors with cooking equipment must have 40B: C fire extinguishers serviced within one year of event.
- Vendors are required to have Thurston County Health Department certification. Health Department phone#: (360) 786-5590
- Any Pro -Food Vendor booth space that dismantles or vacates their booth space prior to 7pm, has not arrived at their assigned check-in time (these are staggered to allow ease of access) or prepared to serve the public by 10am will forfeit their priority status and will not be allowed to participate in the early registration process the following year.
- All vendors are required by the City of Yelm to have a Washington State Business License with a City of Yelm [Endorsement](#) -OR - a Washington State Business License and a completed [Special Event Vendor Pass](#) issued by the City of Yelm.
- **All booths are required to have a copy of your business license posted at the event.**
- A refuse container must be present in the concession area & its contents properly disposed at the conclusion of the event.
- Washington State Food Service Regulation WAC 246-215-120 Sanitary Facilities and Control states, "Food service establishment owners shall dispose of all liquid waste including gray water, mop water and ice melt into an approved on-site sewage disposal system; or in another manner approved by the health officer."
- Water and ice is not provided for Pro-Food Vendors by the Nisqually Valley BBQ Rally.
- Vendors not conforming to any of the above requirements will be required to leave the event immediately.
